## **OTHER VIOLATIONS:**

In January of 2024, we failed to monitor for 1 Coliform Bacteria. Adverse health effects, if any, are not known for this sample. Monitoring procedures have been corrected to avoid future violations. The sample was sent to the lab by mail and had timed out of the proper testing time frame. Samples are no longer being mailed and are now hand delivered to the lab. Additionally, reminders of testing have been added to city staff's calendars so there are more people involved in making sure samples are taken. The city is required to process two samples and we did test one sample which was absent of bacteria.

In January 2024, we failed to monitor for Nitrate. Adverse health effects, if any, are not known. Monitoring procedures have been corrected to avoid future violations. The sample was sent to the lab by mail and had timed out for the proper testing time frame. Samples are no longer being mailed and are now hand delivered to the lab. Additionally, reminders of testing have been added to city staff's calendars so more people are involved in making sure samples are taken. The city does do daily testing for Nitrate with all daily testing below the Maximum Contaminate Level.

## DEFINITIONS

• Maximum Contaminant Level (MCL) – The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

- Maximum Contaminant Level Goal (MCLG) -- The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.
- ppb -- parts per billion.
- ppm -- parts per million.
- pCi/L picocuries per liter
- N/A Not applicable
- ND -- Not detected
- RAA Running Annual Average
- Treatment Technique (TT) A required process intended to reduce the level of a contaminant in drinking water.
- Action Level (AL) The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.
- Maximum Residual Disinfectant Level Goal (MRDLG) The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.
- Maximum Residual Disinfectant Level (MRDL) The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.
- SGL Single Sample Result
- RTCR Revised Total Coliform Rule
- NTU Nephelometric Turbidity Units

## **GENERAL INFORMATION**

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water posed a health risk. If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. LAKE VIEW WATER SUPPLY is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. ## SOURCE WATER ASSESSMENT INFORMATION

This water supply obtains its water from the buried sand and gravel of the Buried Sand and Gravel aquifers. The Buried Sand and Gravel aquifer was determined to be highly susceptible to contamination because the characteristics of the aquifer and overlying materials provide little protection from contamination at the land surface. The Buried Sand and Gravel wells will be highly susceptible to surface contaminants such as leaking underground storage tanks, contaminant spills, and excess fertilizer application. A detailed evaluation of your source water was completed by the Iowa Department of Natural Resources, and is available from the water operator at 712-657-2634.
